Memorandum of Understanding Addendum

This Addendum to the 2020-2021 Memorandum of Understanding (MOU) between Girl Scouts of Northern California (GSNorCal) and Heartwood Charter School (Heartwood) provides the terms and agreements for a WIFI expansion plan. Heartwood wishes to expand the WIFI foot print from the core Internet & WIFI infrastructure provided by GSNorCal at the Bothin facility. Heartwood wishes to install WIFI equipment to extend the WIFI coverage into the Bush/Amphitheater area, the Little House, Manor and Stone House buildings. This extension is comprised of both WIFI equipment installation and Ethernet cable runs to this equipment from the core Comcast modems in each of the buildings.

Nothing in this Addendum modifies Heartwood's responsibility to pay for Internet Services as set forth in the MOU and repeated below:

Internet Services: Heartwood will be responsible for paying monthly internet services from October 13 through June 4. GSNorCal will bill Heartwood directly in One Lump Sum for the school year use per Heartwood request. Pricing will be mutually agreed upon after monthly usage is determined.

Design & Approval:

GSNoral's IT and Property Departments both require prior approval of this expansion plan, specifically where and how the equipment is installed at all locations as well as the ethernet cable runs, prior to the physical installation of this equipment. These departments reserve the right to request modifications to the plan prior to the final approval of the installation portion of this project.

Facilities and Areas Affected:

Core internet modems (Comcast equipment) located in the Dining Hall and Manor Hall will be used to feed the WIFI equipment under consideration. Cabling, radios, antenna and WIFI access points will be installed and equipment mounted to these two buildings. Similar equipment will be installed at the Bush/Amphitheater area, Little House, Manor Hall and the Stone House buildings.

Equipment Administration:

All administrative accounts and passwords will be shared between the GSNorcal IT department and Heartwood or their designated support vendor. Any changes to the configuration of the equipment, including but not limited to SSID names & passcodes shall be immediately shared between the two parties.

Site Alterations:

Heartwood is to use the site as is. Any Improvements that Heartwood makes on any facility will be considered property of GSNorCal and any alterations are to be pre-approved by GSNorCal, namely Tim Burke, Camp Bothin Site Manger.

Equipment Ownership:

The WIFI improvements made at this facility are considered Site Alterations as outline in the original MOU in conjunction with the Rental Agreement and repeated above. All equipment involved in this WIFI expansion shall become the property of GSNorcal.

Heartwood Responsibilities:

- Purchase all equipment, cable and hardware needed to support this project.
- Coordinate the design and review of the project with the vendor of their choice or through GSNorcal's preferred vendor; South Bay Communications 888-525-7767, and with GSNorcal's Acting CIO, Glenn Rogers, 510-562-8470 x1402, grogers@gsnorcal.org and Site Manger Time Burke.
- Coordinate the installation with the vendor of their choice or through GSNorcal's preferred vendor South Bay Communications, 888-525-7767, and GSNorcal's Acting CIO, Glenn Rogers, 510-562-8470 x1402, grogers@gsnorcal.org and Site Manger Time Burke.
- Document all equipment and device configuration along with administrative accounts and passwords.
- Test and provide final sign-off of all equipment installed with vendor of choice.

GSNorCal responsibilities:

- Provide IT and facility support during the design of the equipment installation.
- Provide timely feedback to the design and any requests to modify the installation plans.
- Provide final approval of the installation plans.
- Participate and oversee the installation of all equipment.
- Provide point of contact for any vendor support with Comcast that may be needed.
- Provide support to Heartwood for any core Internet service needs from Comcast.
- Provide best effort support to Heartwood for WIFI related issues.
