Heartwood meaningfully consulted with community members to understand community concern and determine mitigation strategies to address the academic impact of lost instructional time throughout 2021 during the development of the 2021-24 Local Control Accountability Plan (LCAP) and the Expanded Learning Opportunities (ELO) planning process. Community Engagement is also a part of the development of the School Plans for Student Achievement (SPSA) that each school is currently preparing. Heartwood spent time during Board meetings, Parent Councils, Faculty Steering Committee meetings, open Q&A sessions, and Lunch with the Executive Director meetings in order to offer input opportunities to a wide parent English Language Advisory Committees to meaningful consult with individuals and parents representing the interests of students, including underserved groups. Since Heartwood has less than 2% English Learners and Native American populations, no separate community meetings were held for these groups. However, due to the nature of our program, teachers have regular one to one contact with families and are able to ask

about specific needs. The needs expressed in these conversations (primarily concerns around access to technology, isolation / mental health, and additional academic support) are reflected in the plan below.

Throughout the past year input from the community was focused on a multi-dimensional plan to support student’s health and safety at school, social-emotional well-being, mental health, and especially to address the academic impact of lost instructional time by providing new, additional supports during the school day. The strategies in this plan will connect to all of these elements.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
